By signing this document you also renounce any right or capability to recover compensation or to claim any other remedy for any personal or bodily injury, damage to property, death or any other loss or casualty resulting from participation in any activity and/or use of recreational equipment or facilities under the management of Crestwood Hills Pool and Recreation Center at the present date or at any future date.

**Acknowledgment of Risk and Agreement to Participate:**

By participating in leisure, fitness and recreational activities within the recreation facility and in activities such as those governed by the Crestwood Hills Pool and Recreation Center presents inherent dangers and risks both anticipated and unanticipated including all manner of injury (both physical and emotional), paralysis, death, damage to property or to other participants or other losses. Physical injuries from participating in leisure, fitness and recreational activities may include but not limited to: cuts, abrasions, bruising, musculoskeletal injury, heart attack, stroke, head injuries, paralysis, death and the like.

Physical injury may result from any activity involving participation in programs managed by the Crestwood Hills Pool and Recreation Center including but not limited to: overexertion or participation in activities beyond individual skill level, physical or mental capability, failure of equipment, including any other elements of participating in any activity and or use of recreational equipment or facilities under the management of Crestwood Hills Pool and Recreation Center and any neglect to follow established safety policies and procedures by any participant, spectator or any other person.

**Waiver and release of liability:**

Following consideration and recognition of the inherent risks of participation in any activity and or use of recreational equipment or facilities under the management of Crestwood Hills Pool and Recreation Center, I on behalf of myself, my heirs, my estate, guardians, legal representatives, agents and assigns, hereby releasing, waving and forever discharge the Crestwood Hills Pool and Recreation Center, their agents, employees, volunteers or other representatives from any claim of personal injury, damage to property death or any other loss, claim or casualty resulting from participation with the activities or in the use of the facilities at the Crestwood Hills Pool and Recreation Center. I agree to indemnify and hold harmless the Crestwood Hills Pool and Recreation Center or any entities mentioned here in from all liability at the present date or any future date regardless of the circumstances of the claim whether, participation is supervised or unsupervised and whether any breach of contract or duty of care takes place. I understand that this document is legally binding for me as well as the entities mentioned herein and I agree not to sue or otherwise make any claim against the Crestwood Hills Pool and Recreation Center or any entities mentioned herein and the Crestwood Hills Pool and Recreation Center will not be held legally responsible for any loss I may suffer from participation in anyway connected with the center.

**2021 Coronavirus/COVID-19 Release**

The 2019 Novel Coronavirus (COVID-19) is an extremely contagious illness that has been declared a worldwide pandemic by the World Health Organization. As a result, federal, state and local governments and local health agencies may have recommended social distancing and may have placed limitations on the congregation of groups of people. As a result of these recommendations, the Board Members of the Crestwood Hills Pool and Recreation Center have made addendum to the previous rules of the facility in an effort to facilitate the safety guidelines as recommended by the local health department.

By signing this Release, the undersigned member/ parent/ guardian of the individuals utilizing the facility, acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that they and their children may be exposed to or infected by COVID-19 while in attendance at the facility. I understand that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including but not limited to employees of the Crestwood Hills Recreation Center, volunteers and other participants present at the facility.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or my children (including but not limited to personal injury, disability, and death), illness, damage, loss, claim, liability or expense of any kind, that I or my children may experience or incur in connection with our participation and attendance at the Crestwood Hills Pool and Recreation Center. In accordance with the recommendations by the Knox County Health Department Crestwood Hills Pool and Recreation Center encourage the following:

The practice of social distancing as much as possible while utilizing the pools and facilities, allowing 6 feet of space between individuals/families while on the pool deck.

Parents are responsible for supervising and enforcing the social distancing behavior of their minor children. Repeated infractions of the guidelines, may result in management requesting the individual who repeatedly violated the guidelines to exit the premises for the remainder of the day. If the violating individual is an unattended minor, the parent will be notified and a request will be made for the child to be retrieved from the premises. The management has the right to request that the unattended minor not return without a parent or guardian in attendance, thereafter.

Members should evaluate their health status prior to coming to the pool. Each of the following questions should be evaluated for all individuals who will be attending:

- A. Have you or anyone in your household been in close contact with someone with a confirmed case of COVID-19 in the last 14 days?
- B. Are you experiencing cough, shortness of breath or sore throat?
- C. Have you had fever in the last 48 hours?
- D. Have you experienced a loss of taste or smell in the last 24 hours?
- E. Have you experienced nausea, vomiting or diarrhea in the last 24 hours?

If the answer to any of these questions is yes, you may not present to the pool.

It is recommended that names be put on toys, goggles, towels and clothing. Lost and Found items will be discarded weekly.
